**APPOINTMENT OF DEPUTY FIRE CHIEF BY-LAW**

**BY-LAW NO. 06-06**

Enacted on the 8<sup>th</sup> day of August, 2006.

**WHEREAS** the Chippewas of Mnjikaning First Nation has and recognizes its inherent right of self-government and jurisdiction to pass laws and powers, and its authority pursuant to the *Indian Act* to create by-laws providing for the health and safety of the residents on and visitors to the Mnjikaning First Nation Territory;

**AND WHEREAS** the Chippewas of Mnjikaning First Nation has established a professional fire and rescue service to provide fire protection and prevention services within the First Nation;

**AND WHEREAS** the Chippewas of Mnjikaning First Nation Chief and Council have enacted a Mnjikaning Fire Rescue Service Establishing and Regulating By-Law No. 06-04, enacted on the 8<sup>th</sup> day of August, 2006, which sets out the duties and responsibilities of the Deputy Fire Chief;

**AND WHEREAS** Chief and Council appointed Barry Denne as Deputy Fire Chief of Mnjikaning Fire Rescue Service at duly convened meetings on July 12 and 18, 1996, by way of Motion #277, effective July 15, 1996;

**NOW THEREFORE** the Chief and Council of the Chippewas of Mnjikaning First Nation hereby enacts as follows:

**SHORT TITLE**

1. This By-Law may be cited as the "Appointment of Deputy Fire Chief By-Law".

**APPOINTMENT OF FIRE CHIEF**

2. Further to the Mnjikaning Fire Rescue Service Establishing & Regulating By-Law No. 06-04, Chief and Council of Chippewas of Mnjikaning First Nation hereby affirms the appointment of Barry Denne as Deputy Fire Chief of the Mnjikaning Fire Rescue Service to serve until such time as this By-Law is rescinded.




Being the majority of those members of the Council of the Chippewas of Mnjikaning First Nation present at the aforesaid meeting of Chief and Council.
