DO HEREBY RESOLVE  
 DÉCIDE PAR LES PRÉSENTES:

That we, the Chippewas of Rama First Nation council do hereby enact a By-Law for the purpose of increasing or decreasing the speed of motor vehicles from statutory speed limits, to read as follows:

This By-Law to be known as **By-Law No. 88 - 22.**

Whereas subsection 2 of Section 109 of the Highway Traffic Act (R.S.O. 1980, Chapter 198) authorizes the council of a municipality and the trustees of a police village by By-Law to prescribe a speed limit of 40, 50, 60, 70, 80, 90 or 100 kilometres per hour for motor vehicles driven on any highway or portion of highway under its jurisdiction.

And whereas it is deemed expedient that the speed of motor vehicles on certain highways within Rama Indian Reserve # 32 be restricted.

Now therefore the Council of the Chippewas of Rama First Nation council enacts as follows:

- When any highway or portion of highway set out below is marked in compliance with the regulations under the Highway Traffic Act, the maximum rate of speed thereon shall be 50 kilometres per hour.

  - from Simcoe County Road # 44 Westerly including Shriners Drive and Yellowhead Trail;
  - from Simcoe County Road # 44 Westerly on Shriners Drive along the lakeshore to southerly boundary of Indian Subdivision 26-2 in Lot 5 Front Range, situated in Rama Indian Reserve # 32.

2. The penalties provided in subsection 13 of Section 109 of the Highway Traffic Act shall apply to offences against this By-Law known as By-Law No. 88 - 22.
