

# Chippewas of Rama

Ontario - I.R. # 32

By-Law 95-21

A by-law to amend by-law 79-10  
to regulate the use and development of land  
and the character and use of buildings on the Rama Indian

**WHEREAS** paragraphs (f), (g), (h) (l), (l), (n) (q) and (r) of Section 81 of the Indian Act empower the council of a band to make by-laws respecting the use and development of land and the imposition of a penalty for the violation thereof;

**AND WHEREAS** the council of the Rama Indian Band did enact by-law number 76-10 respecting the regulation of use and development of land and the character and use of buildings on the reserve;

**AND WHEREAS** the said council deems it to be expedient and in the best interest of the residents of the Rama Indian Reserve to amend the said by-law;

**NOW THEREFORE** the council of the Rama Band enacts as a by-law thereof as follows:

1. Section 11.4 of by-law 76-10 and the same is hereby amended by deleting the words "\$33.00" in the third line thereof and inserting in lieu thereof the words "\$1,000", so that the said section shall read:
    - 11.4 A person who violates a provision of the By-Law, shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding \$1,000, or imprisonment for a term not exceeding 30 days, or both fine and imprisonment.

Approved and passed at a duly convened meeting of the council, this 14 day of June, 1995.
