# RAMA FIRST NATION Chief Island Permitting Regulation

### Regulation No 21-02 to the Chief Island Bylaw

This Regulation shall come into force and effect on July 21, 2021.

#### Short Title

This Regulations may be called the Chief Island Permitting Regulation.

#### 2. Application

This Regulation applies to all visitors wishing to access Chief Island, as defined in section 3.1 (c) of the Chief Island Bylaw.

#### 3. Permits

#### 3.1. Mooring Permits

- **3.1.1.** The Chippewas of Rama First Nation Lands Department shall receive Mooring Permit applications in the form outlined in Schedule A to this Regulation.
- **3.1.2.** No more than 80 permits will be issued to moor in the waters surrounding Chief Island on any day.

### 3.2. Reconciliation and Education Permits

- 3.2.1. The Chippewas of Rama First Nation Lands Department shall receive Reconciliation and Education Permit applications in the form outlined in Schedule B to this Regulation.
- 3.2.2. Reconciliation and Education Permits will be issued to Visitors who:
  - a. Would like access to the lands of Chief Island;
  - Have developed an educational or reconciliation purpose in collaboration with a member or employee of the Chippewas of Rama First Nation; and

c. Attend at Chief Island only when accompanied by a member or employee of the Chippewas of Rama First Nation.

### 4. Conditions

- 4.1. Upon approval of a permit application, applicants will be required to pay a fee, as outlined in Schedule C to this regulation prior to receiving their permit.
- 4.2. The Chippewas of Rama First Nation Lands Department may issue permits in physical or electronic form.
- **4.3.** Every Permit issued under the Chief Island Bylaw will expire at 8:00 p.m. No overnight mooring will be permitted.
- 4.4. All permit holders will be required to produce their permit in electronic or physical form if requested by bylaw or law enforcement officials.

#### 5. Inappropriate Behavior

- 5.1. No person shall use discriminatory, harassing, abusive or insulting language or gestures or make excessive noise or disturb other persons while in attendance at Chief Island.
- 5.2. No person shall cause harm or damage to Chief Island or anything located on the island, including, but not limited to the cabins, memorial sites, trails, and docks.
- permit holders found to be conducting themselves inappropriately will have their permit revoked and will be asked to leave Chief Island. Failure to leave may result in fine or imprisonment in accordance with section 8.1 of the Chief Island Bylaw.

#### SCHEDULE A— MOORING PERMIT APPLICATION

As the Permit Applicant, you agree to the proper use of the permit if granted, and agree to be present while the permit is in use. Permits will be issued solely for the purpose of mooring and using the waters surrounding Chief Island. The permit will be valid only for the permit holder and boat identified in the permit application.

No person shall access the lands of Chief Island unless that person is a member of the Chippewas of Rama First Nation, accompanied by a Chippewas of Rama First Nation, is an essential service provider as defined in the Chief Island Bylaw No. 21-02, or who has been issued an Education and Reconciliation Permit under the same.
